

RESOLUTION NO. 2010 - 5

**A RESOLUTION SETTING FEES FOR THE USE OF HELPER CITY PROPERTIES,
FOR SPECIAL EVENTS, AND FOR OVERNIGHT CAMPING AND PARKING.**

WHEREAS, the Helper City Council desires to specify by resolution the fees for certain activities which use City properties;

NOW THEREFORE, BE IT RESOLVED by the City Council of Helper City, Utah that the following fees shall be charged for the uses of city properties and facilities as set forth below:

AUDITORIUM

1. ALL MEETINGS - in council chamber room
for up to two (2) hours \$ 25.00
every one-half (½) hour thereafter \$ 10.00
2. UPSTAIRS
Dances, Weddings, Parties \$300.00 (daily)
Commercial Organizations (for profit) \$400.00 (daily)
3. DOWNSTAIRS
Weddings, Parties, Luncheons \$200.00 (daily)
Commercial Organizations (for profit) \$300.00 (daily)
4. DOWN STAIRS KITCHEN \$ 50.00 (daily)
5. FUNERAL DINNERS \$ 75.00 (daily)
6. UPSTAIRS AND DOWNSTAIRS COMBINATION \$1,500.00 (weekly)
(Carnivals, Large Conventions)
7. ALL OTHER SPECIAL ACTIVITIES - fees shall be assessed by City Council or councilperson in charge and approved before held.
8. Deposit of \$500.00 for damage and cleanup is required before activities are held for each floor up and down except for funerals and all meetings.
9. One-half (½) of the deposit shall be forfeited for a cancellation on short notice (less than two (2) weeks in advance).

10. Any tables or chairs taken out of auditorium to be used at other activities, parties, etc., shall be at the rate of \$5.00 per table and \$1.00 per chair (rental fee) and a deposit of \$50.00 held until returned on time and in clean condition as taken. If not, cost of replacement shall be charged.

11. Persons renting space of the auditorium may have access twenty-four (24) hours in advance to decorate if the same does not conflict with other scheduled uses.

CITY PARKS

Any person reserving a park pavilion within Helper City shall pay a flat rate of \$25.00. The person reserving shall also complete the reservation form at the City Recorder's Office and shall abide by all regulations specified in the form.

SPECIAL EVENTS


Any person making an application for a special event shall pay a base application fee of \$200.00. The City Council shall determine the total fee for the event after reviewing the application and determining which city resources shall be required. After the review and determination, the person making the application for the special event shall be required to execute a contract with the City.

OVERNIGHT PARKING, TENT CAMPING, AND RECREATIONAL VEHICLE/TRAILER CAMPING


Any person who desires to use a designated parking or camping location for overnight parking, tent camping, or recreational vehicle/trailer camping shall pay a daily fee of \$10.00. The fee shall be paid at the office of the City Recorder or may be deposited in a fee box if such box is present at the designated area. A map showing designated spaces shall be available at the office of the City Recorder.

These fees shall become effective as of September 2, 2010.
